Qualifications: DVM or equivalent professional degree and eligibility for licensure or faculty certificate to practice veterinary medicine in the State of North Carolina, as well as eligibility for Federal veterinary accreditation.

Responsibilities: The candidate's primary responsibilities will focus on clinical teaching of ruminant production medicine, with an emphasis on beef cattle, and in-depth instruction in ruminant management. The incumbent will assume a service appointment that will be dedicated to extension, primarily focused on the training and education of cow-calf producers in North Carolina. Candidate is expected to collaborate in the design and analysis of research related to infectious diseases and/or food animals/food animal production. The position will include clinical responsibilities mainly through field service including routine reproductive work with both dairy and beef herds and will participate in routine reproductive medicine work provided by the ruminant group to beef and dairy herds.

Strong communication, presentation and writing skills are expected. The successful candidate should have experience in teaching, clinical practice, extension and have some interest in clinically relevant beef cattle research. The incumbent will also be expected to pursue collaborative research.
